IV. MINORS 未成年人

In the case of children, teenagers or people who are subject to legal tutelage under the civil law the visa application form must be signed by both parents, or by those exercising parental authority or guardianship. If the visa application is submitted only by the father or the mother, it is mandatory to submit a notarized authorization from the other parent.

If minors or persons requiring legal guardianship attend by themselves or someone different to their parents, it is mandatory to submit a notarized document in which their parents or legal guardianship authorize the visa application.

In case of minors, the signature will be that of the parents or guardians, or of those exercising parental authority.

In the cases when the applicant presents altered, modified, false documents, or illegally obtained, it will be registered in the migratory data bases and the visa will be denied to enter Mexico.

According to the Immigration Law and its Code, the Mexican visa allows the bearer at the migratory visa verification point, to request the entry into Mexican territory. The Mexican visa does not guarantee the entrance to Mexico, the definitive admission into México is subjected to the authorization of immigration and sanitary authorities at the point of entry, they may verify at any given time, the requirements established in any applicable legal dispositions.

根据法律法规，外国人可以在入境移民审核和申请入境时出示墨西哥签证。出示签证并不保证能成功入境。能否入境墨西哥取决于卫生和移民局的批准。卫生和移民局有权在移民审核的合法权限内随时审核申请人是否符合条件。
