I understand that I may be required to provide my biometric information (fingerprints and facial image) before my application will be processed and that any such information, together with my biographical information, will be collected by the United Kingdom Home Office or another authorised agent on behalf of the Irish Naturalisation and Immigration Service of the Department of Justice and Equality. I agree and consent to this process and to provide my biometric information if required.

I am aware that the Irish Naturalisation and Immigration Service, Department of Justice and Equality is the data controller of the personal data supplied for the purposes of this application. I consent to the personal data supplied being processed by the Irish Naturalisation and Immigration Service, the Department of Foreign Affairs and Trade and any other bodies in accordance with Irish law including data protection law for the purposes of promoting the interests of Ireland and its citizens, maintaining fair and effective immigration controls, including confirming/establishing identity and/or immigration history/criminal history, and preserving and strengthening the Common Travel Area. I consent to the personal data provided being retained by the Irish Naturalisation and Immigration Service for further processing for the above stated purposes. I consent to my biometric and/or biographical information being shared with and retained by the United Kingdom Home Office for further processing in accordance with the law for the purpose of maintaining fair and effective immigration controls across the Common Travel Area.

I agree that the data in my application, and/or any further data supplied, including biometric information and the results of checks carried out on relevant databases, may be disclosed to other Irish Government Departments and/or Agencies, including An Garda Síochána (Irish Police), as well as to public authorities of the Member States of the European Union/EEA and/or other States, including for the purpose of confirming identity and/or immigration history/criminal history.

I understand that I may be recorded by electronic means (CCTV) when I attend at a centre for the purpose of providing my biometrics and biographical details or lodging my documents and that any such recordings may be retained for the purpose of maintaining the integrity of the visa application process.

I understand that additional information may be required before my application can be processed. I understand that failure to provide such data, if requested to do so by the Embassy/Consulate/Visa Office, may result in the refusal of my application.

I understand that any false or misleading information, or false supporting documentation, may result in the refusal of my application without the right of appeal, and that this may result in me being prevented from making further visa applications for a period of up to five years.

I also understand that if I have incorrectly claimed to be exempt from the requirement to provide biometrics my application may be refused without the right of appeal, and I may be prevented from making further visa applications for a period of up to five years.
